The Syntell Water Vending and Management System is an online system that utilises off the shelf hardware and locally created software applications to provide a Water Management system for local, provincial and national government.



The Syntell Water Management System caters for meters from different manufacturers to connect and vend through one system by implementing an open-source protocol.

Syntell Transaction Switch

The Syntell Transaction Switch was created to address the different transport layers and to communicate to the selected system, thereby allowing us to seamlessly integrate numerous outlets under one comprehensive blanket. Through the Syntell gateway, web service requests are accepted, converted to the required protocol, and then redirected to the Vending server.

This platform allows us to accommodate any integration into a number of systems (e.g. the ORT traffic violation system, Conlog / Contour/Actaris Prepayment Systems, Billing systems etc) and utilise our existing vending outlets and e-commerce portal for the receipt of such payments.
